Sub:-Selection for filling up of One Ex-cadre Tenure Post of Vigilance Inspector
/ Traffic in Vigilance Organization.

1. It is proposed to hold a selection for filling up one ex-cadre post of Vigilance Inspector/Traffic in Level-7 (As per 7th CPC) in the Vigilance Organization. Employees working in Traffic department (both Commercial & Operating) in Grade Pay 4600/- & 4200/- are eligible to apply. The post is ex-cadre post and is to be filled up as per ex-cadre norms.
2. Applications are invited in the prescribed proforma (enclosed) from willing and suitable staff.
3. **Wide publicity of the above vacancy notice may kindly be given and this should also be displayed prominently on notice boards for information of the staff.**
4. Controlling officers are requested to forward the applications of eligible staff having sound integrity, good reputation and high caliber. Candidates must have completed at least five years of service as on 30.06.2022.
5. Copies of Service sheets & APARs
To avoid delay and unnecessary correspondence, attested true copies of the updated service sheets and certified copies of the ACRs for the last three years (i.e. period ending 31.03.2022, 31.03.2021 & 31.03.2020) in respect of all the applicants should also be sent to this office in a sealed cover along with the applications latest by **30.08.2022**. Applications received after due date may not be considered.
6. Applications of only those candidates may be forwarded who have not figured/figuring in any vigilance/SPE cases (s). However, it has been clarified vide Railway Board's letter 98/V-1/INSP/1/1 dated 28.04.1998 that following categories can also be considered for induction in Vigilance Organization:-

- a. Where a person was issued a major/minor penalty charge-sheet in a vigilance case but was subsequently exonerated at a later stage in consultation with Vigilance.
 - b. Where a staff who was issued verbal/recorded warning or counseling in a vigilance case.
 - c. Where a staff who was issued verbal/recorded warning or counseling in a vigilance case and at a subsequent stage was exonerated in consultation with vigilance.
7. Working Knowledge of Computer is essential.
 8. Suitability of the candidate will be ascertained through interview/APARs/ credibility. Date of interview will be informed in due course.
 9. Selected candidate will be required to join Vigilance Organization immediately. Normal tenure on ex-cadre post is 03 years extendable up to 05 years in individual cases on special merit. However, administration reserves the right to repatriate them to their parent departments at any time without assigning any reason.
 10. The post is an ex-cadre post and will not confer on selected candidate any claim for such post in preference to their seniors in his parent cadre after his repatriation.
 11. The lien of selected staff will be maintained in parent unit.
 12. Headquarter of Vigilance Inspector will be at Jaipur. The employees who have worked as Vigilance Inspector in the past are not eligible.
