**MEMORANDUM**

Sub: Allotment of higher pay scale of Level-10 (7<sup>th</sup> CPC) [Rs. 15600-39100 with GP Rs. 5400/- (PB-3) as per 6<sup>th</sup> CPC] to Group 'B' Officers- Civil Engg. Dept.

Railway Board vide RBE No. 37/2018 dated 08.03.2018 have issued instructions in supersession of the existing conditions regarding grant of Level 10 to 80% of Group 'B' Officers of all Organised Services including Accounts Department after 3 years regular service, for Group 'B' Officers of all Organised Services other than Accounts Department, the revised scale of Level 10 will now be granted after completion of four years regular service in the grade of Level 8. The revised scale of Level-10 may be operated to the extent of 100% of the Group 'B' Officers on roll including Group 'B' Officers officiating in the revised scale Level 11 on ad-hoc basis (subject to fulfillment of eligibility conditions) in respect of all Organised Services, with effect from the date of publication of these rules i.e. 08.03.2018 and thereafter with effect from 1<sup>st</sup> January and 1<sup>st</sup> July of subsequent years.

Accordingly, the following Group 'B' officers of Civil Engg. Department, working in North Western Railway, is allotted Higher Grade of Level-10 (7<sup>th</sup> CPC) [Rs. 15600-39100 with GP Rs. 5400/- (PB-3) as per 6<sup>th</sup> CPC] as per the procedure for placement envisaged in the Board's letter dated 16.06.2003 with effect from the date as mentioned below :-
